The essay topic is "What Cooperatives Mean to My Community."

Our communities are served by dozens of cooperative businesses. Your family may be members of multiple cooperatives. Your essay may relate to your personal experience or to an overall benefit perspective.

You may use teachers, local cooperative employees and directors, or other resource material as part of your essay. A bibliography is not required.

The essay will be judged primarily on content, but the mechanical structure of the writing shall also be reviewed. Essays may be printed in the ELECTRAWATT newsletter, provided to all RushShelby Energy members each month.

## **School Extra-Curricular Activities**

1 scholarship will be designated for a Shelby County resident for a student attending Morristown, Shelbyville, Southwestern, Triton Central or Waldron High Schools.

1 scholarship will be designated for a resident of the RSE service territory in Bartholomew, Decatur, Fayette, Franklin, Hancock, Henry, or Johnson counties. These students would be attending Batesville, Connersville, Eastern Hancock, Edinburgh, Franklin County, New Palestine, North Decatur, Oldenburg or Tri High Schools.

1 scholarship will be designated as an "at large" award and may go to a student in any of the schools mentioned above.

Less than 4 scholarships may be awarded if not enough qualified applications are received.
