## VI. Reports and Presentations

# A. Principal's Report

Mr. Edwards informed the board that he had been working to complete the schedules for ILEARN, taking into consideration what was best for Southwestern students. He explained that past testing had helped to prepare for the upcoming

test period. Mr. Edwards reminded the board of the upcoming events at the elementary school including the Sparnival and the donkey basketball game that will be a fundraiser for the sixth grade Chicago trip for next year.

Mr. Chase stated that the spring sports' season was off to a great start with the baseball team at a 4-1 record, tennis at a record of 4-0, and several individual track accomplishments. Mr. Chase informed the board that Mr. Meredith was a finalist for The Shelbyville News celebrity of the month and that he had been nominated by a Southwestern student.

## **B. Food Service Director Report**

Mrs. Elliott explained to the board the areas covered by the wellness policy and the requirements that need to be met by this policy. She also explained the updated items included in the Southwestern school wellness policy and what items had been changed. Mrs. Elliott explained that the policy must be formally reviewed every three years and the policy for Southwestern had recently been reviewed by the state. Mrs. Elliott stated that Southwestern had participated in the national school breakfast week by providing free breakfast for our students. She explained that some schools offer free breakfast all year though community eligibility provisions and are based from free and reduced lunch applications. Southwestern's free and reduced application rate does not qualify for this program at this time. Mrs. Elliott explained that she had listened to a senate hearing concerning changes to the school lunch programs for the summer break time period, and that she would keep track of the outcome. Mrs. Elliott informed the board that she had attended the National Legal Action Convention in Washington D.C.. While at the conference she had the opportunity to speak with senators and congressmen and discuss various school food service issues.
