VI. Reports and Presentations

A. Principal Reports

Mr. Edwards shared with the board members some STAR reading data from recent assessments. This data showed that 87% of first grade students tested were at or above the appropriate grade level. Second grade students were at 85% and third grade students were at 82%. He explained that this assessment could be completed on a quarterly or monthly basis as needed.

Mr. Tindall explained to board members that the IXL pilot program that they had implemented at the Jr/Sr High school was proving to be effective. He shared the ISTEP 10+ data that they had recently been given. He explained that this was the graduation qualification for current seniors and that this is the last year that testing would take place. Mr. Tindall informed the board members that all seniors, except two, had passed the language arts testing. He also shared that the area most impacted from learning during the pandemic had been math. Results showed that only 50% of students had passed the math section of testing.

B. Superintendent Report

Mr. Chase shared that he and the principals had attended a professional development session concerning evaluations. The presenter was able to give fresh perspectives and ideas from larger corporations that could be implemented here to help teachers grow. He stated that some of the ideas presented would be implemented during the second semester.
