I. Call to Order

B. Facilities Director Report

Mr. Oliver thanked the board members for the approval to purchase a new lawn mower. He also reflected on some of the larger projects that had been completed including the digital sign, drainage at the wastewater treatment plant, roof replacement almost complete on both schools, high school water heater, and elementary door frames. Mr. Oliver reported to the board on the upcoming projects to be completed during the summer break. These projects included installing new windows in the athletic complex, deep cleaning both schools, upgrading the fire panel at the high school, and adding mulch to the playground among other things.

C. Food Service Director Report

Mrs. Dunbar reported that the cafeteria staff had worked together as a team to accomplish what was needed during the past year including issues caused by the pandemic. She also thanked everyone who pitched in to help during these trying times. Mrs. Dunbar updated board members on some upgraded items for the cafeterias including two new refrigerators, a new milk cooler, new salad bars for each school, an air curtain cooler, and new tables. She also let them know that she had been getting quotes for painting and flooring for the cafeterias. Mrs. Dunbar also explained

that at that time it seemed the waivers that were in place during the pandemic would be dropped for next school year.

Mr. Edwards spoke about the last few days of the current school year. He stated that it was good to see parents back on campus and that everyone had been looking forward to holding field days again. He pointed out that Mr. Guidi had done an excellent job of setting everything up and that parents are being allowed to attend and participate in field day events.
