Mrs. Hoeing reported highlights from January to the school board members. These included an honor roll breakfast with 114 students attending. Mrs. Hoeing reported that to date 49 students had been enrolled, in the first nine days, into preschool, and 36 students had enrolled in kindergarten in less than one week for the upcoming school year. She reported that the enrollment of in-district vs. out-of -district students was close to 50/50 for kindergarten. Mrs. Hoeing let board members know that the elementary school was in the final stages of achieving the paths to quality level one. This will allow Southwestern to

accept vouchers for preschool students, and also opens grant opportunities.

Mr. Tindall informed the board members that staff members were working on SAT intervention based on the PSAT scores received. He stated that all grade levels were now meeting with the counselor to begin to discuss what their career paths look like.

Mr. Edwards reiterated what Mrs. Hoeing spoke about. He explained how Southwestern works together to determine what skills need to be learned at the elementary level to meet the levels required at the high school level.
