Mrs. Hoeing let board members know that all certified positions had been filled, and that she would still be hiring for three aide positions. Mrs. Hoeing let board members know that the elementary school had been granted school wide status for Title 1, previously it was targeted to first and second graders only.

Mr. Tindall thanked Mr. Oliver and his staff for their hard work at the high school. He reported that the school was 90% completed and that the cafeteria walls were being painted at that time. Mr. Tindall reported that his office staff were looking forward to registration the following week and getting kids and parents back into the school. He reported that the state had released data that his staff would be looking at to determine any areas that could be improved. Mr. Tindall stated that he was still looking to fill the art and choir positions at the high school.
