I. Call to Order

A. Pledge of Allegiance to the Flag of the United States of America

Derrek Tennell welcomed everyone in attendance.

D. Recommend to approve the addition of a new position as a grade 2 Teacher. Dr. bourke explained that there were currently 60 first grade students, this position would lower the class size for next year.

E. Recommend to acknowledge that Southwestern Consolidated School Corporation has been placed on the Excessive Education Fund Transfer List. Dr. Bourke explained that this was caused by the form 9 not being filed in January as required by the department of education. He further explained that the form 9 had not been filed because of a late year conversion of the financial software that did not properly move all financial information and the vendor did not get the corrections completed in time to file the form 9.
